### **HURRICANE HELENE REPORT**

Dear St. Anne's Family and Friends,

September 26, 2024 will be a day etched in our memory for years as we witnessed the destruction of Hurricane Helene. We are blessed that Hurricane Helene came, left her mark, and departed with no known loss of life or injury to our family. However, Hurricane Helene definitely left a huge mark at St. Anne's, our families', and much of the Gulf coast. Our hearts and prayers are with them.

St. Anne's has suffered major flooding with at least 18 inches of highly contaminated storm surge (Category 3). The Sanctuary, Parish Hall, Offices, and Garage were all flooded. Mass was cancelled on September 29, 2024. However, we had Mass the following Sunday, October 6, under the Sanctuary canopy.

Currently Mass is being held in the Parish Hall, which began October 13 @ 9:30 am and will remain there until the Sanctuary is repaired (target date Easter). Our surroundings have changed, but Jesus said, "where two or three are gathered in my name, I am there among them (Matthew 18:20)." What truly matters is our faith community has the privilege to worship the risen Christ, Our Lord Jesus.

Days after the devastation of Hurricane Helene, Church Insurance of Vermont (CIC) responded immediately and dispatched two restoration companies (MGM Recovery and One Restore). MGM has completed the assigned remediation tasks. Currently, St. Anne's is still under contract negations with One Restore for the Church Rebuild.

The growing list of damages includes carpeting, tiles, furniture, cabinets, books, doors, and pews. Currently all carpeting, most of the floor tile, four feet of the sheetrock, some cabinets and furniture have been discarded due to flood damages. Although the pews were damaged, there is a possibility they can be repaired. Unfortunately, the list of destroyed items is extensive. On the bright side, many of the church linens, vestments, sacred vessels, prayer books, hymnals, organ, piano, and Audio Visual equipment suffered minimal to no damages.

The financial burden resulting from Hurricane Helene is widespread. We have of course contacted both FEMA and The Diocese of Central Florida. To date, neither FEMA nor The Diocese has offered a certainty of financial support. Any shortfall must be made up by our Investments, which would deplete

most of our savings. The deductibles for our church properties are as follows:

### **Sanctuary Deductible**

- Building \$ 46,910
- Contents \$ 8,106

### **Parish Hall Deductible**

- Building \$ 30,146
- contents \$ 5,178

Our insurance policy has a \$ 1,000,000 flood limit. Preliminary cost for demolition and repairs will exceed \$ 800,000. Much of the cost will be in the rebuild. All buildings will require new flooring, wallboard, doors and cabinets at a minimum. Currently, the list of materials is under review. Our goal is to build back better with water resistant materials.

Over the years, St. Anne's has served the Crystal River and Citrus County Communities through its extensive outreach. What once began as a ministry to homeless veterans grew to a food pantry serving anyone in need, especially during the pandemic. Local children & teens found a friendly face, a warm meal, homework assistance, and friendship here on Sundays, Wednesday evenings, and during the summer. A grand parenting program provided support to local grandparents raising their grandchildren. We are more than a parish that focuses on our own needs.

We at St. Anne's live in and serve this wonderful community of Crystal River. We humbly ask for your financial support in reconstructing the very buildings that have been a haven to many.
